B10. Research Opportunity and Performance Evidence (ROPE) - Career Highlights

My career highlights stem from pioneering the DE22 research methodology, which combines qualitative/quantitative research with innovative co-design methods. This approach led to the creation of significant urban artworks across Australia, most notably "Playful Exchange" (2024) in Preston, Melbourne. This large-scale, intergenerational playable sculpture exemplifies my work's dual function: as contemporary, site-responsive art and as interactive, intergenerational play spaces. This approach has set an industry standard and is being adopted by Councils and artists across Australia.

The impact of this research is evident in the \$2.1 million research income secured between 2020-2024 through partnerships with Aspect Studios, City of Sydney, City of Melbourne and others. Collaborations with industry leaders, such as PlayDMC and Cantilever Engineering, have been crucial in addressing the complex constraints of these projects. The scale and placement of these works requires collaboration and consultation with planning authorities, architects, landscape architects, engineers, design committees, funding bodies, and government agencies. As a result, I have developed significant experience in dealing with public liability issues which encompass design parameters, structural and material constraints and complex site-considerations.

Recognition from major institutions underscores the significance of my work. The National Gallery of Australia (NGA) acquired "Me&You" (2019). These works have also influenced education, with NGA commissioning me to develop a set of educational tools to accompany the playable "The Ludic Folly" sculpture project (2025). The outcome of this will also potentially lead to commercialisation opportunities.

My non-traditional research, through interactive artworks, symposia and publications has sparked interdisciplinary interest by setting an industry standard for playable sculpture nationwide.

I was awarded my PhD in 2008 and have experienced a total of 9 years of career interruptions. My research approach centres on collaborative, interdisciplinary methodologies that bridge art, urban design, and community engagement. This is exemplified by my ARC DECRA project, which addressed the exclusion of children in urban design through partnerships with councils, landscape architects, and urban planners. This research has created a paradigm shift in industry perceptions, evidenced by the subsequent emergence of 'playable sculpture' commissions in Australia.

My collaborative interdisciplinary methodology extends to research training and mentoring. As Research Director at Sydney College of the Arts, I regularly contribute to forums on Non-Traditional Research Outputs across Australian universities. I mentor HDR students and incoming research fellows, such as Dr. Indigo Willing, fostering a new generation of interdisciplinary researchers.

I've built research capacity in my field by developing innovative co-design methodologies that engage communities directly in the urban design process. This approach has led to invitations to join elite urban design teams, such as Aspect Studios' bid for the current \$62 million National Gallery of Australia sculpture park redevelopment.

My work has expanded the boundaries of art research, contributing to broader discussions on risk in child development and inclusive urban spaces, thus building bridges between academic research and practical urban planning.

As Australia's third-ever DECRA recipient in Visual Art (FoR 3606), my research uniquely bridges traditional and non-traditional research outputs (NTROs). This dual approach has positioned me as a national advocate for NTROs' increasing value in the Academic Excellence framework, particularly in terms of engagement and impact.

In Australia's art world, NTROs are categorised as 'nationally significant', 'world class', or 'well above world class'. My outputs consistently achieve top rankings due to:

- 1. Curatorial calibre: Featured in prestigious exhibitions like the 2022 'Know My Name' at the National Gallery Australia.
- 2. Venue recognition: Representation by top tier Australian gallery Sullivan & Strumpf (2018-present).
- 3. Acquisitions: Works acquired by the National Gallery of Australia, Art Gallery of NSW, Museum of Contemporary Art.
- 4. Critical reception: Reviewed in esteemed publications like Art Forum and The Guardian.

My research impact extends beyond traditional metrics:

- Publications: "The Conversation" article on urban child inclusion (80,000+ reads).
- Industry impact: Directly influenced the emergence of 'playable sculpture' commissions nationwide.
- International recognition: Featured in "100 Sculptors of Tomorrow" (Thames and Hudson, 2019).

This multifaceted approach has resulted in a unique research profile that combines academic rigor with real-world impact, contributing significantly to both scholarly discourse and public engagement in contemporary art and urban design.

In early childhood, public spaces and city parks are bastions of gender equality, with adult supervision ensuring fair play.

However, as children grow and gain independence, a stark shift occurs. Adolescent public space and park usage becomes markedly gendered, with boys dominating these spaces while girls' presence wanes. This transformation reflects broader societal influences and challenges us to reconsider how public spaces serve young people of all genders. From age 10, activity levels drop significantly in girls, until by 13-15, only 8% of girls are meeting activity guidelines (FN).

ART/SPORT/URBANISM: Carving Space for Gender-Inclusive Future Cities activates the transformative potential of research driven public art to address the critical issue of genderinclusion in our future cities. ART/SPORT/URBANISM strategically intersects the diverse knowledges of contemporary public art, sociology, urban planning and urban sports to propose innovative solutions for advancing the safety and social inclusion of women and gender diverse individuals in the public sphere.

Significant Problem: The UN New Urban Agenda (Habitat III 2016) recognises gender equality in urban development as crucial for creating livable, equitable, and sustainable cities, and yet Australian cities face a critical challenge in gender inclusivity within public spaces. Women and girls encounter both physical and cultural barriers that limit their full participation in urban life (Kalms 2024, Miles 2021). Urban planning and design play a pivotal role in shaping our environment, which in turn profoundly influences how we live, work, play, move, and rest. Consequently, these processes are directly linked to the structures and behaviours that define our societies, often reflecting and reinforcing existing inequities.

International research shows that excluding women from urban activities perpetuates gender inequality cycles, limiting growth opportunities and undermining confidence (Paetcher et al 2023, Willing and Pappalardo 2023). This leads to women's underrepresentation in urban planning leadership, creating a multi-generational effect on future cities (Kalms 2024). Addressing these issues is essential for fostering inclusive urban spaces that benefit all members of society and break the cycle of inequality in urban environments.

To address this, ART/SPORT/URBANISM tackles barriers to girls' and women's participation in urban spaces in two critical ways:

By developing and integrating feminist-focused, women-led codesign methods into existing and emerging initiatives in urban planning

By further utilising these interdisciplinary co-design methodologies to research and develop interactive, sports-integrated public art objects and urban infrastructure, which contain specific lesign affordances that attract and include diverse user groups, in particular women and girls

Key Research Questions:

- How can the intersection of public art, urban sports, and feminist co-design methodologies create transformative spaces that challenge gender-based exclusion in cities?
- How can we reframe the stigmatisation of 'urban sport' to help communities understand the benefits of sport-integrated public art as an opportunity for gender inclusion and
- What unique methodologies can we develop to bring women into the centre of the urban design process, creating a critical framework and typology for gender-inclusive, sport-

The project, housed in the Sydney Centre for Healthy Societies at the University of Sydney, will bring together diverse interdisciplinary expertise from sociology, sport research, public art, and urban design (see pilot studies 1 and 2, below). Deploying feminist co-design methods (Zamenopoulos, Theodore and Alexiou, Katerina, 2018) the approach will include arts-led collaboration with women, girls, non-binary, and other marginalised users of public space. The research will focus on skateboarding, roller sports, and parkour as case studies to establish a precedent for broader urban sports and leisure activities.

Pilot Studies: This project builds upon two comprehensive pilot studies completed by CI Mestrom, CI Kalms and ARPD Willing in 2024.

Pilot Study 1: 'Art Skate Dots'. Mestrom and Willing collaborated with diverse communities across Sydney to co-design three skateable sculptures through 6 interactive workshops and focus groups, and in consultation with Convic, an award winning skatepark design team. The skateable outcome of this pilot study demonstrates how collaboration between diverse stakeholders (artists, skateboarders, roller skaters, BMX riders) can lead to innovative, culturally significant and multi-purpose additions to the public realm that foster community engagement, enhance accessibility, and contribute to broader urban design initiatives. These prototypes provide a methodological and material foundation for expanded research.

MAGES OF FOCUS GROUP

Pilot Study 2: 'City Canvas.' Dr. Mestrom, Dr. Willing, Odlum (PhD student) and Assoc. Prof. Loke delivered a highly successful two-day symposium titled City Canvas: Public Art, Urbar Play and Creative Sports. This innovative interdisciplinary symposium harnessed the attention brought to skateboarding by its inclusion in the 2024 Olympics, exploring the potential for creative urban sports and public art to come together and empower young adults and non-traditional users to actively shape more diverse, vibrant, and accessible cities. The symposium raised critical questions about inclusion and women's safety in the public realm, which will be addressed in this continued research.

Anticipated New Knowledge: ART/SPORT/URBANISM examines barriers to women and girls participation in the public sphere and addresses them with new methods born at the intersection of public art, urban sports, and gender-sensitive design. The research builds on the knowledge developed through Dr. Mestrom's DE22 'ART/PLAY/RISK', combined with Prof. Kalms publication 'She City: Designing Out Women's Inequity in Cities' and Dr. Willings national initiative 'Skate, Create, Educate and Regenerate' to generate innovative methodologies for feminist co-design for the public realm. By reframing perceptions of urban sports and their potential for fostering social cohesion, ART/SPORT/URBANISM will provide practical strategies and theoretical frameworks for creating transformative urban environments that challenge gender-based exclusion and promote equitable participation in city life.
