








## **NTRO Reporting Changes**

#### In 2024:

- ERA has gone (Excellence Research Australia)
- - IRMA is going (Integrated Research Management Application) storage repository

### So, what has replaced it?

1. A new, simplified Creative Research proforma: https://sydney.au1.qualtrics.com/jfe/form/SV\_8czRVBCXctebcZ8

2. An NTRO panel will be formed, with researchers volunteering for this as part of their 0.2FTE service role. The panel will be administered by FASS Research and led by a senior academic, who will chair the panel.

3. After being accepted into the collection, the creative work will either be minted with a DOI, added to the researcher's ORCiD profile (and stored in the eScholarship Repository), or it will receive a unique URL in the Library catalogue.

- IRMA will be replaced by the library's eScholarship Repository, which has the capacity to mint DOIs for NTROs, allowing for citation of works across research landscapes. For those works that cannot be stored in the repository (for copyright reasons), metadata on the library website will be generated, allowing alternative citation options.
- This enables us to mint our DOI's (our artworks will have the same "shelf presence" as a published book or essay in the library).
- There is also a subsequent possibility to measure influence of these outputs through citation.
- Currently, our research typically only exists on our laptops, sometimes on our private websites, but that's basically it.

WHAT IS A DOI? A digital object identifier (DOI) is a persistent and permanent location identifier for a specific output such as a dataset. The DOI is made up of a string of numbers, letters and symbols which identify the output and provide a permanent link to its location on the web.
